## TE Wealth

Jack Jamieson of TE Wealth discussed a number of items. Firstly, we discussed moving forward with SKL (Max Reed) for the US Tax Withholding issues. We decided to move forward with applying for applicable exemptions and past year refunds. If successful, the refund will far exceed the fee and if the refund is not approved, no fee applies.

Jack then discussed the performance of the Guardian Capital portion of the portfolio. Items discussed were performance, inflation and strategy. It was recommended that a change in the

model to include the Guardian Fundamental Global equity model. This would better diversify the portfolio. The one result of the shift could include a significant one-time capital gain being realized.
